

DISCRETIONARY DONATIONS PROGRAM

In addition to the twice yearly transom grant cycles, BCM also administers a Discretionary Donations program for grant requests of \$5,000 or less. Organizations submitting requests must be located in one of the five parishes served by BCM (Jefferson, Orleans, Plaquemines, St. Bernard and St. Tammany). These small grants are typically in support of fundraising events.

For consideration of a discretionary grant, BCM requires completion of a Discretionary Donations Application Form (see below to print form). These requests are reviewed/approved monthly by the BCM Discretionary Donations Committee. Organizations may apply more than once in a year but are limited to an award of a maximum of \$5,000 per year.
